- 2. The application fee as set forth in this ordinance, in the form of cash, bank, cashiers or certified check, payable to the Town of Northfield.
- 3. A copy of the principal's and any agent's drivers license or other State issued picture identification card.
- 4. A copy of the applicant's, principal's and agent's criminal record from the State in which they reside as well as the State of New Hampshire.
- 5. Application fee.
- 6. For food vendors only, a copy of a State Food License.
- For food vendors only, a statement signed by the Northfield Health Officer certifying that the Health Officer has inspected and approved the applicant's food preparation and preservation system, as well as trash, solid waste and sanitary waste systems.
