- 1. A copy of the applicant's valid New Hampshire Hawkers and Peddlers license
- 2. The application fee as set forth in this ordinance, in the form of cash, bank, cashiers or certified check, payable to the Town of Northfield. Hawkers/Peddlers \$50.00; Itinerant Vendors \$50.00; Circus/Carnival Performance \$100.00
- 3. A copy of the principal's and any agent's drivers license or other State issued picture identification card.
- 4. A copy of the applicant's, principal's and agent's criminal record from the State in which they reside as well as the State of New Hampshire.
- 5. Application fee.
- 6. For food vendors only, a copy of a State Food License.
- 7. <u>For food vendors only</u>, a statement signed by the Northfield Health Officer certifying that the Health Officer has inspected and approved the applicant's food preparation and preservation system, as well as trash, solid waste and sanitary waste systems.

As the applicant for a license to perform hawking and peddling, I understand that I must attach the required paperwork as outlined in the application. By my signature, I state, under penalty of Unsworn Falsification, (RSA 641:3), that the information provided is true and that I have read and understand the ordinance regulating hawking and peddling in the Town of Northfield, New Hampshire.
