- ❖ All applicants who request electricity or sell food must provide a Certificate of Liability Insurance
- ❖ The OHD Committee does not furnish tables or supplies of any kind. Please bring a 10x10 Pop Up Tent for shade.
- ❖ The Old Home Day Committee shall not be held responsible for accidents or injuries which occur at or in conjunction with the booth named on this application.
- ❖ Set up times are Friday, June 28, 2024 from 6:30-8:00 p.m. and Saturday, June 30, 2024 after 7:00 a.m. – **NO EARLY BIRDS ALLOWED.**
- ❖ Booths are expected to stay operational until 3:00 p.m.
- ❖ The OHD Committee reserves the right to limit or forbid the distribution or sale of any items or products at this event.
- ❖ You **MUST CHECK IN** with Booth Organizer **BEFORE** unloading your vehicle. The Booth Organizer has final say on the location of all booth sites.
